## Patron levels

Each Patron level is split into a payment for benefits received and a suggested donation on which the Museum can claim Gift Aid (25p for each £1 you donate\*). The Patron levels are split as follows:

**Platinum:** Minimum value reflects the cost of benefits valued at £400 with a suggested donation of £4,600.

**Gold:** Minimum value reflects the cost of benefits valued at £350 with a suggested donation of £2,650.

**Silver:** Minimum value reflects the cost of benefits valued at £300 with a suggested donation of £1,200.

The benefits package at each Patron level can be purchased separately without contribution of the Patron donation.
